How to Secure Your Solar Funding

- Eligibility verification through ENERGY STAR or DSIRE databases

Beware of outdated information - the Inflation Reduction Act (2022) expanded eligibility to include rental properties and multi-family units in 39 states.

Myth Busting: Common Grant Misconceptions

"Grants are only for new constructions." False. Retrofit projects qualify in 48 U.S. states. "Paperwork takes months." Digital applications now process in 7-10 business days. "Low-income households get priority."

## Q&A: Solar Grant Essentials

### 1. How do I verify grant eligibility?

Check the DSIRE database or consult certified solar providers in your area. Most grants require ENERGY STAR certification.

### 2. Can grants cover battery storage systems?

Yes. The updated ITC now includes \$3,000 credits for solar-plus-storage installations in storm-prone regions like Florida.

### 3. Do grants affect property taxes?

In 31 states, solar installations are exempt from property tax assessments. Always consult local regulations.
