Q: How do I spot fake solar installation reviews?

A: Check for duplicate phrasing across multiple accounts and verify review timestamps against the company's project portfolio.

Q: Do European solar reviews apply to U.S. installations?

A: Not directly. German installations require VDE certification that's irrelevant in North America, while U.S. reviews often reference ITC tax credits.

Q: How long should I monitor reviews before deciding?

A: Track company profiles for at least 6 weeks to identify consistent complaint patterns and response quality.
