How Dehradun Family Saved INR1.2 Lakh Annually

The Rawat family installed a 6kW system under the solar subsidy scheme, reducing their monthly bill from INR8,700 to INR1,200. Their secret? Combining state subsidies with central government tax rebates:

Component	Cost Without Support	Final Cost
Panels	INR2.1 lakh	INR1.4 lakh
Inverter	INR75,000	INR63,000
Installation	INR40,000	INR40,000

Contrary to popular belief, claiming solar subsidies in Uttarakhand requires just three steps:

- Get technical feasibility certificate from DISCOM

Submit bank and property documents to UREDA  
Install through empanelled vendors within 90 days

### Myth vs Reality

While 68% applicants worry about bureaucratic delays, the streamlined portal now approves subsidies in 18 days average - faster than Kerala's solar program.

### Q&A: Solar Subsidies Explained

Q1: Can commercial buildings get subsidies?

Yes! Hotels and hospitals can claim 20% subsidy for systems up to 500kW.

Q2: What about maintenance costs?

UREDA-certified installers provide 5-year free servicing under the scheme.

Q3: How long do approvals take?

Most residential applications get processed within 3 weeks during dry season.
