While the UK leads in VAT exemptions for solar, Italy and Spain offer 10-15% VAT rates with municipal rebates. Germany maintains 19% VAT but offsets it through feed-in tariff programs. For multinational companies, understanding cross-border VAT implications is crucial when deploying solar assets.
